BILL

to provide for the withdrawal of certain further sums from and out of the Consolidated Fund of the State of Goa for the services and purposes of a further part of the financial year 2001-02.

Be it enacted by the Legislative Assembly of Goa in the Fifty-second Year of the Republic of India as follows:-

1. *Short title.*— This Act may be called the Goa Appropriation (Vote on Account)(No. 2) Act, 2001.

2. *Withdrawal of Rs. 2,18,56,71,000 from and out of the Consolidated Fund of the State of Goa for the financial year 2001-02.*— From and out of the Consolidated Fund of the State of Goa, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule amounting in the aggregate to the sum of two hundred eighteen crores, fifty six lakhs and seventy one thousand rupees towards defraying the several charges which will come in the course of payment during the month of July, 2001 in respect of the services and purposes expressed in column (2) of the Schedule.

3. *Appropriation.*— The sums deemed to have been authorised to be paid from and out of the Consolidated Fund of the State of Goa under this Act, shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to further part of the said financial year.
