BILL

further to amend the Goa, Daman and Diu
Agricultural Tenancy Act, 1964.

BE it enacted by the Legislative Assembly of
Goa in the Fifty-Second Year of the Republic of
India as follows:—

1. *Short title and commencement.*— (1) This
Act may be called the Goa Agricultural Tenancy
(Amendment) Act, 2001.

(2) It shall come into force at once.

2. *Amendment of section 2.*— In section 2 of the
Goa, Daman and Diu Agricultural Tenancy Act,
1964 (Act 7 of 1964) for clause (15), the following
clause shall be substituted, namely:—

“(15) ‘Mamlatdar’ means any person
appointed by the Government to perform the
duties of a Mamlatdar under this Act;”.

Statement of Objects and Reasons

In terms of clause (15) of section 2 of the Goa, Daman and Diu Agricultural Tenancy Act, 1964, (Act 7 of 1964), Mamlatdar means any officer appointed by Government to perform the duties of a Mamlatdar under the said Act.

It is proposed to appoint some retired Mamlatdars/Jt. Mamlatdars on contract basis to try and dispose of the backlog of the tenancy cases since there is huge pendency of such cases. It is, therefore, proposed to amend said clause (15) of said section 2 of the said Act, 1964, so as to bring the persons appointed on contract basis, within the definition of "Mamlatdar" under the said Act, 1964.

This Bill seeks to achieve the above objects.

Financial Memorandum

Some retired Mamlatdars/Jt. Mamlatdars are proposed to be appointed on contract basis, in various Talukas. The expenditure on appointment of each Mamlatdar and supporting staff works out to Rs. 19,200/- per month, approximately.

Memorandum Regarding Delegated Legislation

No delegated legislation is envisaged in the proposed Bill.
