BILL

*further to amend the Goa, Daman and Diu
Members of Legislative Assembly (Removal of
Disqualification) Act, 1982 (Act 1 of 1982).*

BE it enacted by the Legislative Assembly of
Goa in the Fifty-fifth Year of the Republic of
India as follows:—

1. *Short title and commencement.*— (1) This
Act may be called the Goa Members of
Legislative Assembly (Removal of Disqualification)
(Amendment) Act, 2005.

(2) Except the entries at serial numbers 15 and
16 of the Schedule which shall be deemed to have
come into force on 2/10/04 and 15/9/04
respectively, the entries at serial numbers 9 to 14
of the Schedule shall be deemed to have come into
force on 1/1/2002.

2. *Amendment of Schedule.*— In the Schedule
to the Goa, Daman and Diu Members of Legislative
Assembly (Removal of Disqualification) Act, 1982
(Act 1 of 1982),—

- (i) The existing entry at serial number 9 shall
be renumbered as 17 thereof;

- (ii) After entry at serial number 8 and before entry at serial number 17 as so renumbered, the following entries shall be inserted, namely:-

" 9. The office of the Chairman and Vice Chairman of the Goa State Infrastructure Development Corporation.

10. The office of the Chairman and Vice Chairman of the State Planning Board.

11. The office of the Chairman of the Goa Khadi and Village Industries Board.

12. The office of the Chairman of the Goa State Scheduled Caste and other Backward Classes Finance and Development Corporation Limited.

13. The office of the Chairman of the Goa State Horticultural Corporation Limited.

14. The office of the Chairman of the Goa Forest Development Corporation Limited.

15. The office of the Chairman of the Goa State Scheduled Tribes Finance Development Corporation Limited.

16. The office of a Parliamentary Secretary.";

(iii) in the proviso, after the words "or corporations" and before the words "is not entitled", the words and figures "as specified at serial number 17 above," shall be inserted.

3. *Repeal and saving.*— (1) The Goa Members of Legislative Assembly (Removal of Disqualification) (Amendment) Ordinance, 2004 (Ordinance No. 2 of 2004), is hereby repealed.

(2) Notwithstanding such repeal, anything done or any action taken in exercise of any power conferred by or under the said Ordinance shall be deemed to have been done or taken in the exercise of the powers conferred by or under this Act as if this Act was in force on the day on which such thing or action was done or taken.
