BILL

to provide for the withdrawal of certain further sums from and out of the Consolidated Fund of the State of Goa for the services and purposes of the financial year 2004-05.

Be it enacted by the Legislative Assembly of Goa in the Fifty-fifth Year of the Republic of India as follows:—

- 1. Short title.— This Act may be called the Goa Appropriation (Vote on Account) (No. 2) Act, 2004.
- 2. Withdrawal of Rs. 6,14,32,00,000 from and out of the Consolidated Fund of the State of Goa for the financial year 2004-05.— From and out of the Consolidated Fund of the State of Goa, there may be paid and applied sums not exceeding those specified in column (5) of the Schedule hereto amounting in the aggregate to the sums of six hundred fourteen crores and thirty two lakhs rupees towards defraying the several charges which will come in the course of payment during the months of July and August, 2004, in respect of the services and purposes specified in column (2) of the said Schedule
- 3.Appropriation. The sums deemed to have been authorised to be paid from and out of the Consolidated Fund of the State of Goa under this Act, shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to further part of the said financial year.
